

Win a Suzuki Terms and Conditions

The "Win a Suzuki" prize competition is a promotion for the 2021/22 Triathlon New Zealand Suzuki National Series and any other events included or excluded deemed by Triathlon NZ* To enter into the prize competition, you must compete in one or more of these events and pay the relevant entry fee. If you are under the age of 18, you must have the consent of a parent or guardian to be eligible.

Entry is only open to New Zealand residents. Members of the Tri NZ Board, employees and their immediate families, paid High Performance contracted coaches, High Performance funded athletes and Tri NZ's associated Sponsors and employees are ineligible to be in the draw to win.

Event Day Entry

Each entry into an Event in the 2021/22 Tri NZ Suzuki National Series will make you eligible for one entry into the draw. One entry per individual and one entry per team. Entry becomes void if the competitor withdraws from the event. If the winner is under the age of 18, a parent or guardian will need to be beside the winner at the presentation of the Tri NZ Suzuki National Series.

At each event, one person will be drawn from all those eligible. The winner from each event will then have a chance to win the Suzuki Swift drawn at the conclusion of the 2021/22 Tri NZ Suzuki National Series

To be eligible for entry into the final draw, you must be present at the prize giving of the 2021/22 Tri NZ Suzuki National Series event you have just competed in. No proxy representation is allowed. The ballot will be re-drawn until a contestant is present to claim the prize. If due to extenuating circumstances the draw cannot occur at the event prize giving, the draw will be drawn randomly and announced through social media and EDM with the winner being directly contacted prior.

In the event of extenuating circumstances including but not limited to Covid-19 and the remaining Tri NZ Suzuki National Series event/s are cancelled, all entrants that had entered the event/s up to and including the date of the cancellation notice, are eligible to go into the draw for that event/s. The draw/s will be drawn randomly and announced through social media and EDM with the winner/s being directly contacted prior.

Final Draw for the prize

The winner of the Suzuki Swift prize will be drawn from those finalists at the conclusion of the 2021/22 series** One winner will be announced. All finalists must be available on site or electronically (phone) to participate in the draw process and accept the prize and furthermore be available for any interviews / media requests.

For the final draw process, if the finalist is not available for the draw, a representative will stand in for the purpose of the draw process only. The finalist will be involved in the draw via phone with that representative relaying the information as the draw process takes place. If the winner is under the age of 18, a parent or guardian will need to be beside the winner at the presentation of the final event.

The vehicle is to be 'registered in respect of the vehicle' in the parent's or guardian's name if the winner is under the age of 18 or does not have a current driver's licence.

There is only one prize of a Suzuki Swift GL Automatic valued at \$22,990 + on road costs. The vehicle will be supplied with 12 months registration and a full tank of fuel.
